TACC is pleased to continue its collaboration with the Boston Housing Authority assisting with the implementation of the Whittier Choice Critical Community Improvements Plan. These federal and city investments in the community will result in small business supports such as storefront improvements and a small business loan fund among other investments.

The Roxbury Cultural District's **Celebrate! 2019** event is scheduled for May 17 and we hope that you will mark your calendar and join us in celebrating the multifaceted expressions of Roxbury's rich cultural diversity.

I am pleased to provide an exciting update on the Comfort Station at 611 Columbia Road in Upham's Corner. Construction in underway and *The Sip and Spoke Bike Kitchen* is anticipated to occupy the space later this year. A special thank you to the many of you who donated to last summer's Commonwealth Places crowdfunding campaign last summer. With your support and the match from MassDevelopment, \$101,770 was raised for the interior buildout making the building fully functional. So, we invite you to frequent this new business.

Connecting People to Place: An Update

WATERWAYS: CONNECTING RESIDENTS OF ROXBURY & NORTH DORCHESTER TO BOSTON'S WATERFRONT

In December, TACC and our Waterways partners, Kelley Chunn & Associates and Denterlein, issued *Findings from Focus Groups with Residents and Stakeholders*. Funded by the Barr Foundation's Waterfront Initiative, Waterways seeks to give voice to residents from Roxbury and North Dorchester to influence programs, policies, and accessibility to ensure that, as the waterfront continues to evolve, the needs and interests of these communities are considered and implemented.

Findings from Focus Groups with Residents and Stakeholders is a summary document that shares key themes about the Boston Waterfront elicited from residents of Roxbury and North Dorchester as well as stakeholders. In six focus groups, participants identified perceptions of, experiences on, interests in, and barriers to accessing the waterfront. Four focus groups were held with residents of public and subsidized housing communities. Two additional focus groups were held; one with neighborhood stakeholders and the second with downtown Boston waterfront stakeholders.

In two-hour structured conversations, participants discussed and identified key issues and themes related to familiarity and perceptions, experiences, current use, public access, barriers, inclusivity, and climate change.

Participants offered a range of specific suggestions to reduce barriers and create a more inclusive waterfront over the short-, mid-, and long-terms that include expanding publicity and outreach in the neighborhoods; developing maps and resources that visualize connections between all of Boston's residents and the waterfront; and improving transportation options to the waterfront for recreation and employment.

Additional findings and action items can be found in the full summary document.

The focus groups are one phase of a six-phase, 18-month project that seeks to 1) Expose and engage Roxbury and North Dorchester residents to the potential recreational, social, educational, economic, and environmental opportunities for their communities along the waterfront; and 2) Gather resident input to improve the understanding of what it would take to develop a stronger waterfront connection.

This summer and fall, TACC partnered with housing communities and neighborhood organizations to develop trips that encourage Roxbury and North Dorchester families to participate in existing waterfront activities which have included harbor cruises with Boston Harbor Now (BHN) and the National Park Service (NPS); and visits to the New England Aquarium. By providing transportation, translation, and food, Waterways removed some of the barriers to participation. Data collected through pre and post-surveys helps us learn more about residents' experiences on Boston's waterfront.

In September, TACC partnered with African Community Economic Development of New England (ACEDONE) on a trip that brought a group of Somali families to Spectacle Island. The group participated in the Fall Frolic, a day of activities on the island organized by Save the Harbor/Save the Bay, BHN and the NPS.

On May 18, 2017, the Roxbury Cultural District (RCD) was formally designated as Boston's third cultural district and will provide the sustained, collaborative focus on activating and marketing the neighborhood's arts and cultural resources, strengthen collective impact, and expand the potential economic opportunities for residents, artists, business owners, and entrepreneurs.

As one partner instrumental in establishing the RCD, TACC has continued to support the RCD's transition into an independent non-profit.

A COMMUNITY-DRIVEN ECONOMIC COLLABORATION: COMFORT STATION

For the past three years, TACC supported the redevelopment of the historic Comfort Station in Upham's Corner by surveying residents about local needs, providing pre-development services and fundraising. 611 Columbia Road is now under construction! Developed by Historic Boston, Inc., it is anticipated to open in the spring. When the doors open, Noah Hicks De Amor's *The Sip & Spoke Bike Kitchen* will bring a comfortable community space and a reasonably priced café and bike repair services to the neighborhood.

In addition, he is responsible for the asset management of the Corcoran Jennison existing real estate portfolio, which is comprised of over 100 real estate partnerships with a value in excess of \$4 billion.

Michael is a past or present member of several industry organizations including Urban Land Institute Multi-Family Council, National Multi-Family Housing Council, Mortgage Bankers Association, Pension Real Estate Association, and the National Housing Roundtable.
